#### **1. Process and outcomes**

- Vision building process initiated in 2024
  - Preparatory work
    - Lessons learned and good practices from EBU projects
    - o Literature
    - o Ongoing debate...
  - Workshop in Vienna (14/15 October 2024)
  - Rounds of discussion on outcomes of the workshop
  - Writing process
    - o (around 50+ experts involved from EBU & associate partners)
- o Output
  - Position paper (EU consultation)
  - Reflection paper





#### 2. Bioeconomy vision, ambition, drivers, motivations

- Start from definition...
- …and got into broad discussion on understanding of bioeconomy systems:
  - High-level ambitions/aspirations (quality of life, health,...)
  - Motivations and drivers (climate change, planet boundaries...)
  - Technologies (diversity, acceptance, strategic focuses...)
  - Societal transformation (social innovation, system organization, regulation...)

#### <u>3. Role of HEI</u>

- Central role of HEI in bioeconomy innovation systems
- Reshaping each HEI mission
  - Research (co-developed, long term, cutting edge topics...)
  - Education (skills, T-shaped, student-centred, Msc/Phd as pivot, all ages, teach the teachers, ...)
  - Third mission/impact (public engagement, industry collaborations,...)
- Integration among the 3 missions
  - o e.g. FOEBE/DESTINY students/supervisors
- Need for rethinking our approach into transformative players (bioeconomy specific)





#### <u>4. The EBU Alliance vision in support of the EU Bioeconomy</u> <u>Strategy – in short:</u>

- Promote the role of HEIs and research to boost this innovative and competitive sector
- Deploy circular bioeconomy multi-disciplinary education programmes and projects
- Increase EU funding on bioeconomy R&I in the FP10
- Support structural activities beyond specific education or research projects
- Set up a coherent policy framework supporting circular bioeconomy R&I
- o Support the EU in achieving an epochal shift towards the Green Transition
- ...with a leading role in global collaborations



#### 5. Final thoughts

- Positive/constructive vision joining practical solutions and ambitious aspirations (with limits in mind)
- Live with definitory challenges: look at open spaces for collaboration/contribution rather than boundaries
- Transformative approach & focus on persons: changemakers through a changing concept and in dialogue with society
