#### The Reasoning




- Bio-based Economy and Circular Economy become substantial elements for the future development and growth in Europe

#### **New Elements**




- Common Approach on Societal, Economic & Environmental needs

- Teaching the Teachers



#### **Strategic Objectives**

- Increase awareness and understanding: Increase the general awareness and understanding of the concepts, principles, and potential of bioeconomy among students, educators, and the general public in the BIOEAST macro-region
- Enhance curriculum integration: Embed bioeconomy-related topics into the curricula of different disciplines (e.g., biology, chemistry, economics) at various educational levels.
- Build interdisciplinary expertise: Foster interdisciplinary collaboration and develop bioeconomy-specific courses or programs to equip students with the necessary knowledge and skills to navigate the complexities of the bioeconomy
- Promote research and innovation: Encourage and support research activities
  focused on bioeconomy-related topics, including the development of innovative
  technologies, sustainable production methods, and efficient resource management.
- Establish industry-academia partnerships: Facilitate collaborations between educational institutions and bioeconomy industries to ensure that education aligns with the needs and demands of the bioeconomy sector.
- Foster entrepreneurship and start-ups: Promote entrepreneurship within the bioeconomy sector by developing initiatives, such as business incubators or entrepreneurship programs, to support students and graduates in launching their own bioeconomy-related ventures.
- Strengthen international cooperation: Facilitate cross-border collaboration and knowledge exchange with international

The Network of Bioeconomy Universities in the BIOEAST macro-region – BIOEAST Uni Net Concept Paper & Action Plan



BIOEAST HUB CZ as an operative managerial body of the BIOEAST Uni Net

- continued in the discussion about the cooperation with ICA / CoP, EBU, EC
- invited universities from both BIOEAST macro region and also Western Balcan countries
- represented the newly established interwork in the national and international events (f.e. EU Conference on Knowledge Valorisation Prague May 23; ICA – CoP & Boku May 23 workshop on BOKU; international summer school in Thesaloniky July 2023)
- was developing BIOgovNET, BIObec and CASCADE projects that support circular bioeconomy education
- participated and arranged involvement of BIOEAST Uni Net members into several project proposals focused on bioeconomy education, some projects are at the stage of grant agreement preparation (once the GA is singed, more information will be disclosed)

- 2023, 24, 25 Participation in HE projects


